Sub: Complaint against Duty Magistrate Ekta, for not taking complaint of ill-treatment on record and directed accused to give the same in writing. However, when accused prepared complaint in writing she left the court without recording the compliant of accused and without referring the accused to medical hospital.

Ref.: F.I.R. NO 343/2017, dated 19.08.2017 and production of accused before court of Duty Magistrate Ekta on 20.08.2017.

Respected sir,

With reference to the above cited subject, I the above named applicant/complainant most respectfully submit my grievance for taking action against the Magistrate who deliberately did not take complaint of ill-treatment of accused at the hands of Police.

That, I am Chandrakala Thakur Wd/o. Indrakant Thakur 1. (Address: House No. 14060, Street No. 2, Ram Nagar, Tibba Road, Ludhiana -141007 Mob. 79735-71454) Mother of one of the accused namely Mukesh Thakur. That previously a complaint was lodged by Lucky Gupta alias Jaihind (Doctor by profession) about illegally withdrawal of Rs. 11861/- from his Paytm account. However, with great efforts, they both search about the illegal withdrawal, they came to know from the concern bank that the said amount has been illegally withdrawn by One Amritpal Singh alias Vicky. Therefore, they filed a complaint with ACP/East Ludhiana and also Commissioner Ludhiana. Therefore the said person and his relatives came to settle the dispute. However, when they were asked to tender unconditional apology and submit their bank statement, so as to check that previously they did not cheated other persons. Being aggrieved by the said action of my son and

Lucky, the brother of cheater, who is food inspector intervene in the matter and threatened them that he was having good relation with Commissioner of Police, and can implicate them in many offences.

- 2. That, the complaint of cheating and forgery filed by Lucky for fraud, cheating and forgery, was not investigated by police, despite having clear proof and bank proof. It was incumbent upon the Police to register F.I.R. against the said cheater, but they danced to the tune of senior police officials, who are good friends of said food inspector.
- 3. On 19.8.2017, they both were arrested by police in the morning at about 5.00a.m. but despite whole day passed, police did not produce them. When I tried to know under which offence/crime they came to be arrested, then the police officers insulted and threatened me with dire consequences if I insist to know details about their arrest. They were taken to CIA office where again we tried to meet my son and Lucky, but neither police allowed us to meet nor they inform us about the reasons of their arrest. Therefore I filed a complaint about the same in the court of Duty Magistrate Ekta. Copy of the said complaint is annexed herewith for ready reference.

However, when my son and Lucky produced before the concern Magistrate, they explained the beating and assault by police and orally informed the court/Magistrate about ill-treatment at the hands of Police. The said Magistrate did not record anything and directed to give the complaint in writing. It took 8/10 minutes for them to write the complaint, but till that time the Magistrate left the court and did not take complaint of ill-treatment on record nor referred the accused to medical hospital though they complained about the same.

It is to be noted that my son Mukesh were badly beaten by police, even Lucky was not able to stand up before court. All these atrocities they have committed when Punjab State Human Rights Commission directed the Commissioner of Police, Ludhiana to conduct enquiry about illegally handcuffing of the accused and paraded in the locality.

- 4. Needless to say that all the magistrate and judges are also to follow the rules of law and for that purpose only they are being handsomely paid. If any magistrate shows bias towards police and avoids submissions of the accused to take on record, then such officers become menace to the society and do not deserve to be chaired highly dignified posts of judges and magistrate, as the same acts create doubts in the minds of general people they lose confidence in judicial system.
- 5. Therefore, You are humbly requested to look into the matter and conduct enquiry against the magistrate and see that whatever, she might have stated in her orders are not correct, as far as illtreatment complaint is concern. Needless to mention that complaint to appropriate authorities against arbitrary and highhandedness of the police are being sent. I hope that your Honor will conduct enquiry without being influenced by police and magistrate. Kindly let me know the result of the enquiry.
